2. ALL FIRE EQUIPMENT TO BE SERVICED AND MAINTAINED - SERVICED ANNUALLY.
3. ALL ESCAPE ROUTES TO BE KEPT CLEAR AT ALL TIMES, ESCAPE DOORS TO BE FITTED WITH APPROVED LOCKING DEVICES, CAPABLE OF BEING OPENED FROM THE INSIDE WITHOUT A KEY DURING BUSINESS HOURS.
4. FIRE EQUIPMENT AND ESCAPE ROUTES ARE CLEARLY SIGN POSTED.
5. LP GAS INSTALLATION ARE INSTALLED AS PER SABS 078 AND EMERGENCY MANAGEMENT SERVICES BY -
