STATUTORY COUNCIL FOR THE FAST FOOD, RESTAURANT, CATERING AND ALLIED TRADES

FAST FOOD, RESTAURANT, CATERING AND ALLIED TRADES

The Statutory Council has been registered by the Department Labour on 14 December 2012 with registration number LR 2/6/8/10 in terms of section 30 read with section 40(3)(b) of the Labour Relations Act, 66 of 1995, as amended and accredited by the CCMA to deal with disputes and conditions of employment for parties to the council. Parties to the council have signed a collective agreement and the agreement shall remain in force for the period ending 31st August 2019.

The areas of operation are: Western Cape, Northern Cape, Kwa Zulu Natal, Eastern Cape, and Northern Province excluding Warmbaths, North West Province, excluding the Magisterial Districts of Brits and Rustenburg and Mpumalanga excluding Witbank.

The parties to the Council are CATRA, SACCAWU, DUSWO, HOTELICA, FOSAWU, HICRAWU, FEDCRAW and FAWU.

The purpose of the Council is to have speedy dispute resolution, monitor the terms and conditions between the parties, to have a forum for negotiation, and conclusion of substantive agreements on wages, benefits and other conditions of employment between the parties.

Benefits of the Council includes the saving of costs for employers and employees not having to go through the lengthy process of Conciliation, Con –arb and Arbitration by going through the process of an inquiry by an arbitrator. Other benefits include a provident and funeral fund available to members. For more enquiries interested parties can contact the Council direct.

In order for the Council to administer its functions and service delivery, an amount of R8.00 is collected from employers and R8.00 from employees per month, as well as an additional establishment fee of R25.00 per month from employers.
